### 2.0 ETHICAL SOURCING AND FAIR-TRADE POLICY

#### 2.1 Introduction

The Pan African Association of Recycling and Secondhand Textiles (PARST) is dedicated to promoting ethical practices in the sourcing and distribution of secondhand textiles and recycled materials across Africa. This policy outlines our commitment to fair labor practices, non-exploitative working conditions, and environmental responsibility throughout our supply chain.

# 2.2 Objectives
